

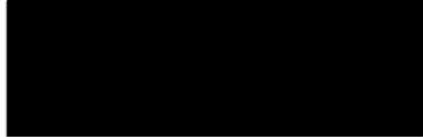

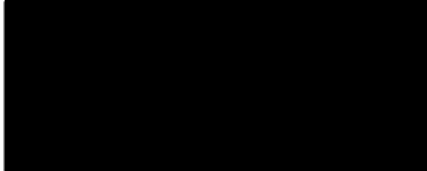

REQUEST FOR EVIDENCE

IMPORTANT: THIS NOTICE CONTAINS YOUR UNIQUE NUMBER. THE ORIGINAL NOTICE MUST BE SUBMITTED WITH THE REQUESTED EVIDENCE.

You are receiving this notice because U.S. Citizenship and Immigration Services (USCIS) requires additional evidence to process your form. Please provide the evidence requested below.

Your response must be received in this office by October 29, 2021.

Please note that you have been given the maximum period allowed for responding to a Request for Evidence (RFE). The time period for responding cannot be extended. See 8 Code of Federal Regulations (8 CFR) 103.2(b)(8)(iv). **Because many immigration benefits are time sensitive, you are encouraged to respond to this request as early as possible, but no later than the above deadline.** If you do not respond to this notice within the allotted time, your case may be denied.

You must submit all requested evidence at the same time. If you submit only some of the requested evidence, USCIS will consider your response a request for a decision on the record. See 8 CFR 103.2(b)(11).

Processing of your I-485 will resume upon receipt of your response. If you have not heard from USCIS within **60 days of responding**, you may contact the USCIS Contact Center at **1-800-375-5283**. If you are hearing impaired, please call the USCIS Contact Center TDD at **1-800-767-1833**.

Requested item: Form I-693, Report of Medical Examination and Vaccination Record is required to complete your Form I-485, Application to Register Permanent Residence or Adjust Status. Your Form I-693 medical exam has either not been submitted yet, or your existing Form I-693 was signed by the civil surgeon more than two years ago and is expired. Please submit a new Form I-693 completed by a designated civil surgeon to this office together with a copy of this notice. Including a copy of this notice will facilitate matching your medical report with your file.

Important Warning: Only a designated civil surgeon authorized by USCIS to conduct medical examinations is qualified to complete Form I-693. Only the current or most recent version of the form will be accepted. The civil surgeon must sign and date the Form I-693. Signatures by a nurse or physician's assistant are not acceptable. You must also sign and date the Form I-693 when instructed to do so by the civil surgeon. When appropriately completed and signed, the **original** Form I-693 must be sealed in a separate envelope by the civil surgeon. The sealed envelope must be returned, unopened, to this office with any other requested evidence.

Failure to submit a response is grounds for the denial of your application. A response is required regardless of whether an immigrant visa is currently available to you. USCIS may, if necessary, separately request additional evidence not listed above in order to finalize your case. Even though you have 87 days to respond to this Request for Evidence, the sooner you respond the sooner USCIS may be able to finalize your adjustment.

Please note: if you have already submitted a recent Form I-693 to USCIS in response to a different RFE or on your own, you must still reply to this RFE. Include a brief explanation of when and where your I-693 was sent plus copies of any document(s) you have from that submission.
